## <u>EQUITY</u>


A total turnover of 1.559 billion shares worth N36.497 billion in 42,546 deals was traded this week by investors on the floor of the Exchange, in contrast to a total of 2.478 billion shares valued at N47.856 billion that exchanged hands last week in 54,982 deals.

The Financial Services Industry (measured by volume) led the activity chart with 1.127 billion shares valued at N18.908 billion traded in 19,424 deals; thus contributing 72.27% and 51.81% to the total equity turnover volume and value respectively. The Conglomerates Industry followed with 117.400 million shares worth N1.508 billion in 2,775 deals. The third place was the Consumer Goods, with a turnover of 98.422 million shares worth N4.008 billion in 6,322 deals.

Trading in the top three equities namely United Bank for Africa Plc, FBN Holdings Plc and Guaranty Trust Holding Company Plc(measured by volume) accounted for 389.286 million shares worth N11.757 billion in 5,372 deals, contributing 24.96% and 32.21% to the total equity turnover volume and value respectively.

### INDEX MOVEMENT


The NGX All-Share Index and Market Capitalization appreciated by **3.79%** to close the week at 105,722.78 and N57.850 trillion respectively.
