MARKET REPORT FOR MARCH 28TH, 2024

PRODUCTS

EQUITY

The market opened for four trading days this week as the Federal Government of Nigeria declared Friday March 29, 2024 and Monday April 1, 2024 as Public Holidays to commemorate Easter celebration.


Meanwhile, a total turnover of 1.804billion shares worth N52.040 billion in 38,550 deals was traded this week by investors on the floor of the Exchange, in contrast to a total of 1.735 billion shares valued at N48.755 billion that exchanged hands last week in 45,237 deals.

The Financial Services Industry (measured by volume) led the activity chart with 1.329billion shares valued at N32.924 billion traded in 20,897 deals; thus contributing 73.65% and 63.27% to the total equity turnover volume and value respectively. The Conglomerates Industry followed with 106.728 million shares worth N1.467 billion in 2,368 deals. The third place was the Consumer Goods Industry, with a turnover of 87.708 million shares worth N4.220 billion in 4,731 deals.

Trading in the top three equities namely Guaranty Trust Holding Company Plc, Zenith Bank Plc and Access Holdings Plc (measured by volume) accounted for 589.939 million shares worth N23.276 billion in 8,166 deals, contributing 32.70% and 44.73% to the total equity turnover volume and value respectively.
