NPF MICROFINANCE BANK PLC – DELAY IN FILING AUDITED FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2023, UNAUDITED FINANCIAL STATEMENTS FOR THE PERIOD ENDED 31ST MARCH 2024 AND FOR THE PERIOD ENDING 31ST JUNE 2024

NPF Microfinance Bank Plc (NPF Microfinance or the Bank), hereby wishes to notify our shareholders and the investing public that the Bank has been unable to file its Audited Financial Statements (2023 AFS) for the year ended 31 December 2023 and consequently will be unable to file the Unaudited Financial Statements for the period ended 31st March 2024 (1st Quarter) and for the period ending 31st June 2024 (2nd Quarter) before the regulatory deadline of 30th April 2024 and 31st July 2024 respectively.

The delay is to enable Inlaks Ltd and the Deloitte Data Analytics team ensure that necessary adjustments are mirroring figures on both side so as to resolve the material differences which surfaced when the Data Integrity exercise which involved the comparison of the figures on GL lines generated from the T24 with the same GL lines on the data base generated on the Deloitte Data Analytics platform was carried out. This is to enable the Bank have an accurate report for the rendition of the 2023 AFS, 1st Quarter and 2nd Quarter 2024 statutory returns.

We wish to assure the entire public, our stakeholders, investors, and regulators that the Unaudited Financial Statements for the period ended 31st March 2024 and for the period ending 31st June 2024 will be released after the filing of the 2023 AFS and not later than 30th July 2024 and 30th September 2024 respectively. An extension of time has been sought from the NGX Regulation Limited (NGX RegCo) to allow for late filing of the 1st Quarter and 2nd Quarter financial statements in view of the reasons adduced above.
