NOTICE OF 51ST ANNUAL GENERAL MEETING

NOTICE IS HEREBY GIVEN THAT the 51st Annual General Meeting of **LEARN AFRICA PLC** (the "Company") will be held at 52 Oba Akran Avenue, Ikeja, Lagos on Thursday, 26th September 2024 at 11.00 a.m. prompt to transact the following business:

ORDINARY BUSINESS:

1. To receive the Audited Financial Statements for the year ended 31st March 2024, together with the reports of the Directors, Auditors and the Statutory Audit Committee thereon.
2. To declare a Bonus Issue of one (1) share for every eight (8) ordinary shares of ₦0.50k to existing shareholders of the Company whose names are registered in the Company's Register of Members at the close of business on Friday, 6th September 2024 for the Financial Year ended 31st March 2024.
3. To re-elect Directors retiring by rotation.
4. To authorize the Directors to fix the Remuneration of the external Auditors.
5. To disclose the Remuneration of the Managers of the Business.
6. To elect members of the Statutory Audit Committee.

SPECIAL BUSINESS:

7. To approve the remuneration of Non-Executive Directors for year 2024/2025.
8. Pursuant to the provisions of the Companies and Allied Matter Act 2020, and the Memorandum and Articles of the Company, that the issued share capital of the Company be increased from 771,450,000 to 867,881,250 by the creation of 96,431,250 units of ordinary shares of ₦0.50k each, ranking pari-passu in all respects with the existing shares in the Company's equity.
9. To authorize the Board and Management to do all acts and take all actions to give effect to the above resolutions subject to all and any regulatory authorization that may be required.

10. To authorize the Board and Management to take all steps to amend Clause 6 of the Memorandum and Articles of Association of the Company to comply with Resolution 8 above to read:

"the Share Capital of the Company is N433,940,625 divided into 867,881,250 ordinary shares of ₦0.50k each".

11. To approve the amendment of the Company's Memorandum and Articles of Association to permit directors to conduct Board Committees, Board Meetings and General Meetings via teleconference by passing the following resolution:

"That the Company's Memorandum and Articles of Association be and is hereby amended to permit directors to conduct Board Committees, Board Meetings and General Meetings via teleconference"

- **Proxy:** Any member of the Company entitled to attend and vote at this meeting is also entitled to appoint a proxy to attend and vote in his/her stead. A proxy need not be a member of the Company. For the appointment of the proxy to be valid, a Proxy Form must be completed and deposited either at the office of the Registrars, First Registrars and Investors Services Limited Plot 2, Abebe Village Road, Iganmu, Lagos not later than 48 hours before the time fixed for the meeting. - **Live Streaming of the AGM:** Pursuant to the provisions of the Business Facilitation (Miscellaneous Provisions) Act 2022, which allows public companies to hold meetings electronically, the 51st Annual General Meeting will be held virtually. - **Bonus Issue** A bonus issue of one (1) share for every eight (8) ordinary shares of ₦0.50k has been recommended by the Board of Directors for the approval of the shareholders of the Company whose names are registered in the Company's Register of Members at the close of business on Friday, 6th September 2024.
- **Closure of Register and Transfer Books:** The Register of Members shall be closed from 9th to 14th September 2024, (both days inclusive) for the purpose of updating the Register of Members.
- **Nomination of Statutory Audit Committee Members:** In accordance with Section 404(6) of the Companies and Allied Matters Act 2020, any member may nominate a shareholder as a member of the Statutory Audit Committee by giving notice in writing of such nomination to the Company Secretary at least twenty-one (21) days before the Annual General Meeting.
