**ANNOUNCEMENT - FIDELITY BANK Q4, 2023 UNAUDITED FINANCIAL STATEMENT**

Fidelity Bank Plc (the Bank) wishes to inform the investing public and Nigerian Exchange Limited, that after the upload of the Bank's Q4, 2023 Unaudited Financial Statements, it noticed that the negative sign attributable to the tax value of ₦20,766 million was inadvertently omitted hence increasing the value of the Profit After Tax of the Group for December 2023 to ₦142,828 million instead of reducing it to ₦101,296 million.

The affected areas are highlighted below in red and has been corrected, preparatory for a further upload.
