

## SUMMARY OF TRANSACTIONS AS AT 31 JULY 2023<sup>1</sup>

Note the increase in the total value of transactions from March to July 2023.

On a monthly basis, Nigerian Exchange Limited ("NGX") polls trading figures from market operators on their Domestic and Foreign Portfolio Investment (FPI)<sup>4</sup> flows. As at 31 July 2023, total transactions at the nation's bourse increased by <u>72.83% from <del>1406.75billion</del> (about \$537.87million) in June<sup>5</sup> 2023 to <del>1702.98billion</del> (about \$911.91million) in July<sup>6</sup> 2023. The performance of the current month when compared to the performance in July 2022 (**1101.18billion**) revealed that total transactions increased by **594.78%.** In July 2023, the total value of transactions executed by Domestic Investors outperformed transactions executed by Foreign Investors by circa **88%** as shown in figure **1** below.</u>

#### ANALYSIS OF DOMESTIC AND FOREIGN TRANSACTIONS FOR THE MONTH (JULY'23)



A further analysis of the total transactions executed between the current and prior month (June 2023) revealed that total domestic transactions increased by **83.50%** from <del>N</del>361.01billion in June to <del>N</del>662.44billion in July 2023. However, total foreign transactions decreased marginally by <u>11.37% from</u> <del>N45.74billion (about \$60.49million) to N40.54billion (about \$52.58million)</del> between June 2023 and July 2023.

#### ANALYSIS OF DOMESTIC TRANSACTIONS

Figure 4 below shows that Institutional Investors outperformed Retail Investors by 30%. A comparison of domestic transactions in the current and prior month (June 2023) revealed that retail transactions



increased by **84.67%** from <del>N</del>124.52billion in June to <del>N</del>229.95billion in July 2023. Similarly, the institutional composition of the domestic market increased by **82.88%** from <del>N</del>236.49billion in June 2023 to <del>N</del>432.49billion in July 2023.




## HISTORICAL ANALYSIS OF DOMESTIC AND FOREIGN TRANSACTIONS

The data in figure **7** below highlights the performance of the market over the last decade. Over a sixteen (16) year period, domestic transactions decreased by **45.30%** from <del>N</del>3.556t in 2007 to <del>N</del>1.945t in 2022 whilst foreign transactions also decreased by **38.47%** from <del>N</del>616bn to <del>N</del>379bn over the same period.

Total domestic transactions accounted for about 84% of the total transactions carried out in 2022, whilst foreign transactions accounted for about 16% of the total transactions in the same period.

The transaction data for 2023 shows that total domestic transactions are circa H1.968trillion, whilst total foreign transactions are circa H185.62billion.
