

DOMESTIC & FOREIGN PORTFOLIO PARTICIPATION IN EQUITY TRADING

On a monthly basis, Nigerian Exchange Limited ("NGX") polls trading figures from market operators on their Domestic and Foreign Portfolio Investment (FPI)⁴ flows. As at 30 June 2021, total transactions at the nation's bourse increased by <u>3.68% from N97.19billion (about \$236.33million) in May 2021⁵ to</u> <u>N100.77billion (about \$244.88million) in June 2021</u>⁶. The performance of the current month when compared to the performance in June 2020 (N128.88billion) revealed that total transactions decreased by **21.81%.** In June 2021, the total value of transactions executed by Domestic Investors outperformed transactions executed by Foreign Investors by circa **54%** as shown in figure **1** below.

ANALYSIS OF DOMESTIC AND FOREIGN TRANSACTIONS FOR THE MONTH (JUNE'21)



A further analysis of the total transactions executed between the current and prior month (May 2021) revealed that total domestic transactions increased by **0.59%** from N76.90billion in May to N77.35billion in June 2021. Similarly, total foreign transactions increased by <u>15.43% from N20.29billion (about</u> <u>\$49.33million) to N23.42billion (about \$56.91million)</u> between May 2021 and June 2021.



ANALYSIS OF DOMESTIC TRANSACTIONS

Figure **4** below shows that Institutional Investors outperformed Retail Investors by **6%**. A comparison of domestic transactions in the current and prior month (May 2021) revealed that retail transactions increased by **9.47%** from N32.94billion in May 2021 to N36.06billion in June 2021. However, the institutional composition of the domestic market decreased by **6.07%** from N43.96billion in May 2021 to N41.29billion in June 2021.



HISTORICAL ANALYSIS OF DOMESTIC AND FOREIGN TRANSACTIONS

The data in figure **7** below highlights the performance of the market over the last decade. Over a fourteen (14) year period, domestic transactions decreased by **59.54%** from N3.556t in 2007 to N1.439t in 2020 whilst foreign transactions increased by **18.45%** from N616bn to N729bn over the same period.

Total domestic transactions accounted for about 74% of the total transactions carried out in 2020, whilst foreign transactions accounted for about 26% of the total transactions in the same period.

The transaction data for 2021 shows that total foreign transactions are circa N221.96billion, whilst total domestic transactions are circa N812.46billion.




Figure 7: Foreign/Domestic 14-year Trend (2007 – Date)
