

SUMMARY OF TRANSACTIONS AS AT 31 OCTOBER 2021<sup>1</sup>

On a monthly basis, Nigerian Exchange Limited ("NGX") polls trading figures from market operators on their Domestic and Foreign Portfolio Investment (FPI)<sup>4</sup> flows. As at 31 October 2021, total transactions at the nation's bourse increased by 80.34% from N118.15billion (about \$285.81million) in September 2021<sup>5</sup> to H213.07billion (about \$513.31million) in October 2021<sup>6</sup>. The performance of the current month when compared to the performance in October 2020 (N244.90billion) revealed that total transactions decreased by 13%. In October 2021, the total value of transactions executed by Domestic Investors outperformed transactions executed by Foreign Investors by circa 60% as shown in figure 1 below.

#### ANALYSIS OF DOMESTIC AND FOREIGN TRANSACTIONS FOR THE MONTH (OCTOBER'21)



A further analysis of the total transactions executed between the current and prior month (September 2021) revealed that total domestic transactions increased by 81.93% from N93.80billion in September to ₦170.65billion in October 2021. Similarly, total foreign transactions increased by 74.21% from N24.35billion (about \$58.91million) to N42.42billion (about \$102.21million) between September 2021 and October 2021.



#### ANALYSIS OF DOMESTIC TRANSACTIONS

Figure 4 below shows that Institutional Investors outperformed Retail Investors by **32%**. A comparison of domestic transactions in the current and prior month (September 2021) revealed that retail transactions increased by **83.69%** from <del>N</del>31.76billion in September 2021 to <del>N</del>58.34billion in October 2021. Similarly, the institutional composition of the domestic market increased by **81.03%** from <del>N</del>62.04billion in September 2021 to <del>N</del>112.31billion in October 2021.




#### HISTORICAL ANALYSIS OF DOMESTIC AND FOREIGN TRANSACTIONS

The data in figure **7** below highlights the performance of the market over the last decade. Over a fourteen (14) year period, domestic transactions decreased by **59.54%** from <del>N</del>3.556t in 2007 to <del>N</del>1.439t in 2020 whilst foreign transactions increased by **18.45%** from <del>N</del>616bn to <del>N</del>729bn over the same period.

Total domestic transactions accounted for about 74% of the total transactions carried out in 2020, whilst foreign transactions accounted for about 26% of the total transactions in the same period.

The transaction data for 2021 shows that total foreign transactions are circa N329.62billion, whilst total domestic transactions are circa N1.215t.
