SUMMARY OF TRANSACTIONS AS AT 30 JUNE 2024¹

On a monthly basis, Nigerian Exchange Limited ("NGX") polls trading figures from market operators on their Domestic and Foreign Portfolio Investment (FPI)⁴ flows. As at 30 June 2024, total transactions at the nation's bourse decreased marginally by <u>0.23% from 1355.38 billion (about \$239.56 million) in May⁵ 2024 to</u> 1354.55 billion (about \$241.06 million) in June⁶ 2024. The performance of the current month when compared to the performance in June 2023 (1406.75 billion) revealed that total transactions decreased by **12.83%.** In June 2024, the total value of transactions executed by Domestic Investors outperformed transactions executed by Foreign Investors by circa **54%** as shown in figure **1** below.

Figure 1: Domestic vs. Foreign Participation Fig







Figure 3: Outflow (N'Bn)



A further analysis of the total transactions executed between the current and prior month (May 2024) revealed that total domestic transactions increased by **17.85%** from ****231.10 billion in May 2024 to ****272.36 billion in June 2024. However, total foreign transactions decreased by **<u>33.87%</u>** from ****124.28 billion (about \$83.78 million) to ****82.19 billion (about \$55.88 million) between May 2024 and June 2024.

ANALYSIS OF DOMESTIC TRANSACTIONS

Figure 4 below shows that Institutional Investors outperformed Retail Investors by 16%. A comparison of domestic transactions in the current month and prior month (May 2024) revealed that retail transactions

increased by **0.43%** from ¥113.53 billion in May 2024 to ¥114.02 billion in June 2024. Similarly, the institutional composition of the domestic market increased significantly by **34.68%** from ¥117.57 billion in May 2024 to ¥158.34 billion in June 2024.




HISTORICAL ANALYSIS OF DOMESTIC AND FOREIGN TRANSACTIONS

The data in figure **7** below highlights the performance of the market over the last decade. Over a seventeen (17) year period, domestic transactions decreased by **10.94%** from N3.556 trillion in 2007 to N3.167 trillion in 2023; whilst foreign transactions also decreased by **33.28%** from N616 billion to N411 billion over the same period.

Total domestic transactions accounted for about **89%** of the total transactions carried out in 2023, whilst foreign transactions accounted for about **11%** of the total transactions in the same period.

The transaction data for 2024 shows that total domestic transactions are circa N2.064 trillion, whilst total foreign transactions are circa N540.48 billion.
