#### **Facts And Figures**

The Exchange's trading hours are from 9:30am to 2:30pm (West Central Africa time). Equities are listed under 11 industry sectors including (i) Agriculture; (ii) Conglomerates; (iii) Construction/Real Estate; (iv) Consumer Goods; (v) Financial Services; (vi) Healthcare; (vii) ICT; (viii) Industrial Goods; (ix) Natural Resources; (x) Oil and Gas; and (xi) Services. NGX has 15 indices that track market and sector performance; they consist of NGX All Share Index (ASI), NGX 30 Index, NGX Pension Index, NGX Banking Index, NGX Consumer Goods Index, NGX Industrial Index, NGX Insurance Index, NGX Oil and Gas Index, NGX Lotus Islamic Index, NGX Premium Board Index, NGX Main Board Index, NGX ASeM Index, NGX Corporate Governance (CG) Index, NGX Growth Index, and NGX Sovereign Bond Index. The main index is NGX 30 Index.

The Exchange closed the first half of 2021 in negative downturn, following the reallocation of assets from Equities to Fixed income as a result of the uptick in yields in the Fixed Income market during the period. This can be seen in the return posted by NGX All Share Index which closed the quarter at 37,907.28 points, signifying a 5.87% decrease from 40,270.72 points at the start of the year. Nonetheless, all equity market indices, except the NGX ASEM index, posted positive one-year returns.

In Q2 2021, trading activities decreased when compared with Q2 2020 as the total volume and value of securities traded reduced by 15.41% and 5.41% respectively. There was a 5.41% decrease in the average daily value traded from N3.22 billion (\$8.33 million) in Q2 2020 to N3.05 billion (\$7.40 million) in the period under review. Similarly, the average daily volume of securities traded fell by 15.41% to 245.97 million units in Q2 2021 when compared with 290.77 million units recorded in Q2 2020.

At the end of the quarter, the average PE ratio of The Exchange's listed equities stood at 164.73 while equity turnover velocity was 3.53%.
