

MARKET REPORT FOR SEPTEMBER 1ST, 2023

PRODUCTS

EQUITY

A total turnover of 2.510 billion shares worth N32.816 billion in 40,736 deals was traded this week by investors on the floor of the Exchange, in contrast to a total of 1.812 billion shares valued at N29.299 billion that exchanged hands last week in 31,163 deals.

The Financial Services Industry (measured by volume) led the activity chart with 1.228 billion shares valued at N11.711 billion traded in 15,583 deals; thus contributing 48.92% and 35.69% to the total equity turnover volume and value respectively. The Conglomerates Industry followed with 573.483 million shares worth N3.975 billion in 4,377 deals. The third place was the Consumer Goods Industry, with a turnover of 228.833 million shares worth N10.607 billion in 9,303 deals.

Trading in the top three equities namely Transnational Corporation Plc, Sterling Financial Holdings Company Plc and Fidelity Bank Plc (measured by volume) accounted for 927.042 million shares worth N5.677 billion in 6,043 deals, contributing 36.93% and 17.30% to the total equity turnover volume and value respectively.

INDEX MOVEMENT


The NGX All-Share Index and Market Capitalization appreciated by 3.00% to close the week at 67,527.19 and N36.958 trillion respectively.
