PRODUCTS


A total turnover of 1.137 billion shares worth N10.812 billion in 23,471 deals was traded this week by investors on the floor of the Exchange, in contrast to a total of 1.289 billion shares valued at N13.546 billion that exchanged hands last week in 22,118 deals.

The Financial Services Industry (measured by volume) led the activity chart with 798.246 million shares valued at N6.732 billion traded in 12,904 deals; thus contributing 70.23% and 62.26% to the total equity turnover volume and value respectively. The Conglomerates Industry followed with 155.154 million shares worth N228.975 million in 917 deals. The third place was The Consumer Goods Industry, with a turnover of 45.341 million shares worth N1.013 billion in 2,819 deals.

Trading in the top three equities namely Fidelity Bank Plc, Transnational Corporation Of Nigeria Plc, and Zenith Bank Plc (measured by volume) accounted for 454.800 million shares worth N2.551 billion in 4,587 deals, contributing 40.01% and 23.60% to the total equity turnover volume and value respectively.
