
A total turnover of 1.447 billion shares worth N73.889 billion in 39,546 deals was traded this week by investors on the floor of the Exchange, in contrast to a total of 2.966 billion shares valued at N31.508 billion that exchanged hands last week in 42,482 deals.

The Financial Services Industry (measured by volume) led the activity chart with 886.971 million shares valued at N16.943 billion traded in 17,045 deals; thus contributing 61.31% and 22.93% to the total equity turnover volume and value respectively. The Oil and Gas Industry followed with 257.578 million shares worth N52.067 billion in 9,798 deals. Third place was the Services Industry, with a turnover of 69.620 million shares worth N330.878 million in 2,069 deals.

Trading in the top three equities namely Japaul Gold and Ventures Plc, United Bank for Africa Plc and Zenith Bank Plc (measured by volume) accounted for 420.318 million shares worth N8.417 billion in 5,146 deals, contributing 29.05% and 11.39% to the total equity turnover volume and value respectively.


INDEX MOVEMENT

The NGX All-Share Index and Market Capitalization appreciated by **0.48% and 5.95%** to close the week at 98,070.28 and N59.425 trillion respectively.

Similarly, all other indices finished higher with the exception of NGX CG, NGX Banking, NGX Insurance, NGX AFR Bank Value, NGX MERI Value and NGX Sovereign Bond which depreciated 0.21%, 0.51%, 1.23%, 0.09%, 0.65% and 3.29% respectively while the NGX ASeM index closed flat.
