
A total turnover of 3.575 billion shares worth N107.011 billion in 146,429 deals was traded this week by investors on the floor of the Exchange, in contrast to a total of 7.479 billion shares valued at N145.429 billion that exchanged hands last week in 159,487 deals.

The Financial Services Industry (measured by volume) led the activity chart with 2.946 billion shares valued at N65.904 billion traded in 62,817 deals; thus contributing 82.39% and 61.59% to the total equity turnover volume and value respectively. The Services Industry followed with 147.325 million shares worth N1.511 billion in 7,656 deals. Third place was the Consumer Goods Industry, with a turnover of 147.307 million shares worth N11.195 billion in 18,644 deals.

Trading in the top three equities, namely Fidelity Bank Plc, FCMB Group Plc, and Aso Savings & Loans Plc (measured by volume), accounted for 1.288 billion shares worth N19.300 billion in 11,536 deals, contributing 36.03% and 18.08% to the total equity turnover volume and value respectively.


INDEX MOVEMENT
